All bids must be accompanied by proposal guaranty in the form of a Certified or Cashier’s Check, or Bidders Bond drawn to the order of the City of Alvin, and in the minimum amount of five percent (5%) of the total amount of the bid. No proposal may be withdrawn for a period of ninety (90) days after receipt of bids except with the approval of the City of Alvin. The City of Alvin reserves the right to reject any or all bids or to accept any bid from any responsible person which will be most advantageous to it and results in the best and most economical completion of the proposed improvements, facilities, works, equipment and appliances. The successful bidder will be required to provide a Performance Bond and Payment Bond in full amount of the contract.

Attention is called to the fact that not less than, the federally determined prevailing (Davis-Bacon and Related Acts) wage rate, as issued by the Texas Department of Agriculture Office of Rural Affairs and contained in the contract documents, must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, age or national origin. Adherence to the grant recipient’s Section 3 Policy is required for contracts and subcontracts in excess of \$100,000.00
