

INVITATION TO BIDDERS

Sealed Bids addressed to Sienna Municipal Utility District No. 5, Attention: Mr. Joe Price, President, Board of Directors, will be received electronically **or** at the office of LJA Engineering, Inc., 1904 West Grand Parkway North, Suite 120, Katy, Texas 77449, until 10:00 a.m. Local Time, Tuesday, September 24, 2024, and then publicly opened and read at the office of the Engineer, LJA Engineering, Inc., 1904 West Grand Parkway North, Suite 120, Katy, Texas 77449 for "Paving and Appurtenances to Serve Sienna Parkway Section 6 for Sienna Municipal Utility District No. 5, Fort Bend County, Texas." Scope of Work of the Contract Documents includes the following: paving and appurtenances.

Bids received after the closing time will be returned unopened. Attendance by each prospective bidder or its representative at the pre-bid conference is **MANDATORY**, and no Bid will be opened unless the bidder or representative was present at the pre-bid conference.

Each Bid must be accompanied by a Bid bond or a certified or cashier's check, acceptable to the Owner, in an amount not less than two percent (2%) of the total amount Bid, as a guarantee that the successful bidder will enter into the Contract Documents and execute the Bonds on the forms provided and provide the required insurance certificates and Bonds within seven (7) days after the date Contract Documents are received by the successful bidder. If a certified or cashier's check is provided, the successful bidder shall deliver, at the bid opening address, the *original* certified or cashier's check within one (1) business day of receipt of the bid opening.
