INVITATION TO BIDDERS

Sealed Bids, in duplicate, addressed to Sienna Plantation Levee Improvement District of Fort Bend County Texas, Attention: Kendall Beckman, President, Board of Directors, will be received at the office of the Engineer, LJA Engineering, Inc., 1904 West Grand Parkway North, Suite 120, Katy, Texas 77449, until 2:30 p.m. Local Time, Thursday, April 29, 2021, and then publicly opened and read for “Construction of the Channel 3 Deepening for Sienna Plantation Levee Improvement District of Fort Bend County Texas, Fort Bend County, Texas”. Bidders may elect to submit bids electronically via <https://bids.lja.com>. Due to the pandemic and Federal guidelines of not gathering in groups of more than 10 people, people of the public who wish to attend the Bid Opening must do so by telephone. Scope of Work of the Contract includes channel deepening excavation.

Bids received after the closing time will be returned unopened. Attendance by each prospective bidder or its representative at the pre-bid conference is **MANDATORY**, and no Bid will be opened unless the bidder or representative was present at the pre-bid conference either in person or teleconference.

Each Bid must be accompanied by a bid bond or a certified or cashier’s check, acceptable to the Owner, in an amount not less than 5 percent of the total amount bid, as a guarantee that the successful bidder will enter into the Contract and execute the Bonds on the forms provided and provide the required insurance certificates within 7 days after the date Contract Documents are received by the Contractor.
