Sealed Bids, in duplicate, addressed to Brazoria County Municipal Utility District No. 83, Attention: Mr. Todd Casper, President, Board of Directors, will be received at LJA Engineering, Inc., 1904 West Grand Parkway North, Suite 120, Katy, Texas 77449, until 10:00 a.m. Local Time, Tuesday, October 21, 2025, and then publicly opened and read for "Construction of the Water, Sanitary Sewer and Drainage Facilities and Paving and Appurtenances to Serve Valencia Section 11 for Brazoria County Municipal Utility District No. 83, Brazoria County, Texas". Bidders may elect to submit bids electronically via <https://bids.lja.com>. Bidders must register and obtain bidding documents on this website for the required payment amount (if any) to submit an electronic bid. Scope of Work of the Contract includes the construction of the water, sanitary sewer, drainage facilities and paving and appurtenances.

Each Bid must be accompanied by a bid bond or a certified or cashier's check, acceptable to the Owner, in an amount not less than 5 percent of the total amount bid, as a guarantee that the successful bidder will enter into the Contract and execute the Bonds on the forms provided and provide the required insurance certificates within 7 days after the date Contract Documents are received by the Contractor.
