SEALED PROPOSALS addressed to GRBK Edgewood LLC on behalf of Denton County Municipal Utility District No. 7 for construction of both the Utility Improvements for Stillwaters, Phase 1 and the Paving Improvements for Stillwaters, Phase 1, LJA Job No. NT340-0411, will be received electronically via <https://bids.lja.com>, until 12:00 p.m., Thursday, May 28, 2026 and then publicly opened and read aloud. Bidders must register on this website to submit an electronic bid. Contractors will electronically enter into the bid proposal, found at <https://bids.lja.com>, their proposed pricing and upload only the bid security. The contractors can bid on both contracts, but it is not required. Separate bid proposals shall be submitted for each project. Contracts will be awarded separately. Electronic bids do not include bids submitted by telegraphic or facsimile transmission. The bids will be publicly opened at the office of LJA Engineering, Inc., located at 6060 North Central Expressway, Suite 400, Dallas, Texas 75206.
