NOTICE IS HEREBY GIVEN that Online bids will be received by the Village of Ruidoso, New Mexico, for construction of the Taxiway A LED MITL System at Sierra Blanca Regional Airport (SRR) through QuestCDN. Electronic bidding will open on **August 24, 2026, at 9:00 a.m. (MT)** and will close on **August 26, 2026, at 11:00 a.m. (MT)**. All bidders submitting bids electronically must be registered with QuestCDN. Bid results will be available through QuestCDN within one (1) hour after the bidding deadline. An in-person public reading of the bids will be held after the bid deadline at Village Hall, 313 Cree Meadows Drive, Ruidoso, NM 88345.

BID SCHEDULES: The Project includes one (1) bid schedule, each representing a distinct Scope of Work. The bid schedule is identified as follows:

➔ **Schedule 1: Taxiway A LED MITL System**

The Bid Schedule is described in greater detail in the Bidding Documents and Bid Proposal Forms.

DESCRIPTION OF THE WORK. The project is anticipated to be funded, in whole or in part, by grants from the NMDOT and Federal Aviation Administration. The Work consists of construction, rehabilitation, and/or improvements of Taxiway A LED MIRT System, as shown on the Plans and described in the Contract Documents. The Work will interface with existing airport facilities and infrastructure, as applicable. The limits of construction and general site conditions are illustrated on the plans.

AVAILABILITY OF CONTRACT DOCUMENTS. A digital download of the Contract Documents and other related contract information is available for purchase online at www.questcdn.com for \$42.00, payable directly to QuestCDN. This cost includes access to online bidding. **No refunds will be issued.** The QuestCDN project number is **10268533**. Bid quantities and schedules can be viewed prior to purchase by selecting the "View Bid Documents" option on QuestCDN.

BID SECURITY. Each online bid submission must include a PDF copy of a Bid Bond, executed by a Surety Company, in an amount not less than five percent (5%) of the total bid, made payable to the Village of Ruidoso, New Mexico, and uploaded to QuestCDN as part of the bid submission process.

BID SUBMISSION REQUIREMENTS. Bidders are required to provide all information requested in the proposal forms and specifications and must submit bids on all items within every schedule. The Village of Ruidoso, New Mexico, reserves the right to waive any informality or to reject any or all portions of bid items. No bid may be withdrawn for a period of one hundred twenty (120) days following the bid opening.

PRE-BID MEETING. A non-mandatory in-person pre-bid meeting will be on **August 12, 2026, at 11:00 a.m. (MT)** at the Sierra Blanca Regional Airport (SRR) Terminal Building, 1000 State Highway 220, Ruidoso, New Mexico, 88312. Following the pre-bid meeting, prospective bidders will have the opportunity to tour the project site.

The FLSA sets minimum wage, overtime pay, recordkeeping, and child labor standards for full and part-time workers.

The Contractor has full responsibility to monitor compliance to the referenced statute or regulation. The Contractor must address any claims or disputes that arise from this requirement directly with the U.S. Department of Labor – Wage and Hour Division.

STATE WAGE RATES. Minimum wage rates as established by the Secretary of Labor and State of New Mexico shall apply to all schedules awarded for this project.
