The project is being bid turnkey. Contractors shall submit a bid to include the excavation, utility and paving improvements. One contract will be awarded for the combined sum of the excavation, utility and paving sections of the bid. Electronic bids do not include bids submitted by telegraphic or facsimile transmission.
